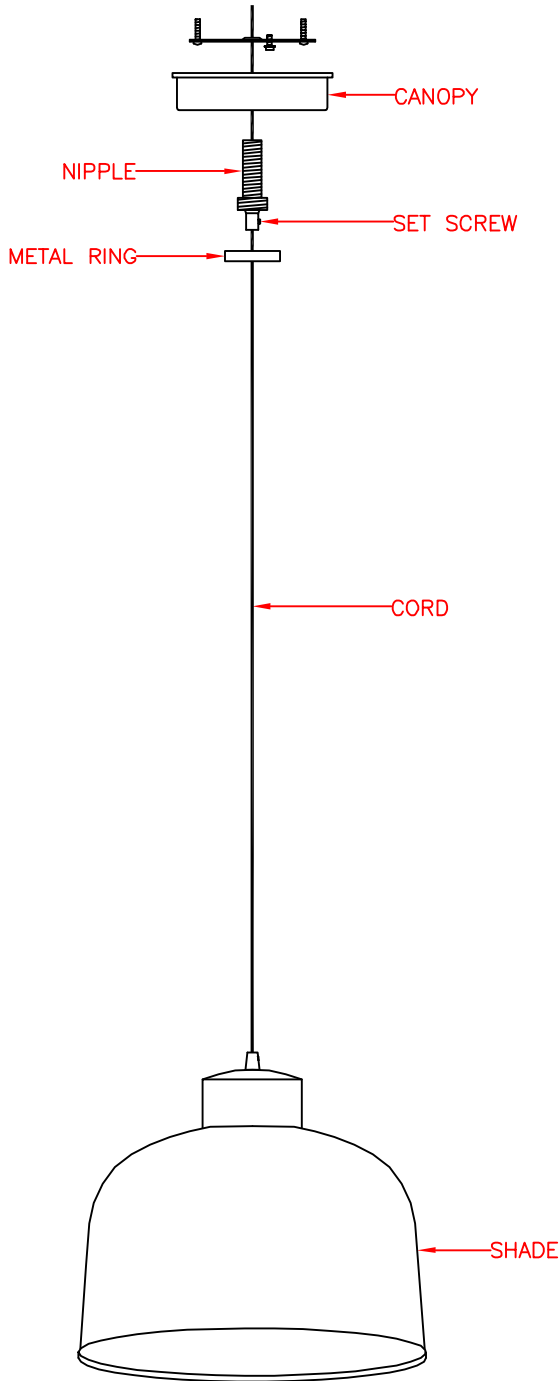

OVERALL ASSEMBLED DIMENSIONS

HEIGHT: 35.6 CM (14"), WIDTH: 38.1 CM (15") DIA.

1 LIGHT: UL LISTED, 100 WATT, MEDIUM BASE E-26 CERAMIC SOCKET.

CANOPY: PAINTED STEEL, 13.3 CM (5-1/4") DIA. x 4.4 CM (1-3/4") HEIGHT.

CORD: UL LISTED, 305 CM (10 FT.) LENGTH, 18 AWG., 3 CONDUCTORS, TYPE SVT CLOTH CORD, 105°C, BROWN COLOR, WIRES MUST BE LEAD FREE.

SHADE: STEEL, PAINTED IN RUST FINISH, 38.1 CM (15") DIA. MAX. x 35.6 CM (14") HEIGHT, SHAPED AS SHOWN.

LABELS: UL, CSA OR CUL, MANUFACTURING DATE, MODEL # AND COUNTRY OF ORIGIN LABELS PROVIDED IN CANOPY. RELAMPING LABEL FOR 100 WATT MAX. TYPE "A" BULB PROVIDED NEAR SOCKET.

PACKAGING AND SHIPPING DETAILS

THE PENDANT IS ASSEMBLED FOR SHIPPING. THE WHOLE PENDANT IS CAREFULLY WRAPPED IN A PLASTIC BAG AND PLACED SECURELY IN THE INNER PACKING SO IT CAN NOT MOVE AROUND DURING SHIPPING. A SMALL BAG OF SILICA IS INCLUDED IN THE PACKAGE.

HARDWARE PACK #002 PROVIDED. ALL PARTS SHOULD BE SECURED SO THEY CAN NOT MOVE DURING SHIPPING.

THE CARTON IS MADE OF DOUBLE WALL, CORRUGATED CARDBOARD "A MA A". BROWN IN COLOR. THE INNER PACKING IS DIE-CUT CARDBOARD OR STYROFOAM TO PROTECT AND SECURE THE LAMP AND MUST PASS THE FEDEX AND ISTA-3A DROP TEST REQUIREMENTS.

EACH CARTON SHALL BE PRINTED WITH A LINE DRAWING AND THE KENROY HOME NAME AND LOGO, MODEL NUMBER AND FINISH, EACH CARTON SHALL BE PROVIDED A UPC LABEL. THE UPC BAR CODE AS FOLLOWS: 053392064105.

MODEL 92071RST INSTRUCTIONS ARE TO BE PACKED WITH EACH LAMP. INSTRUCTIONS MUST BE PRINTED CLEARLY ON QUALITY PAPER.
